## **DID YOU KNOW?**

The IRS mileage reimbursement rate has increased to \$0.365.

House Bill 108 passed on November 13, 2001, amending the current NCGS 161-31 regarding tax certification, requiring the register of deeds in certain counties (as specified in the statute) not to accept any deed transferring real property for recording unless the county tax collector has certified that no delinquent taxes are owing. Be sure to check out this revised language.

The fees payable to the Register of Deeds for recordation have increased effective January 1, 2002. New formatting standards have also been established, effective July 1, 2002. Contact your local Register of Deeds Office for information.
