What area of law should I pursue? How do I gain experience? How much can I expect to make? What advice do you have for someone considering changing careers? These are just a few of the questions that I commonly see from current paralegal students. My answer is this: You're in the best position you could possibly be in.

As a student, you have the opportunity to take advantage of several paralegal associations with free membership or a nominal fee. As such, you're able to attend seminars in different practice areas and most importantly—network. You may have your heart set on civil litigation but after attending a seminar learn that it was nothing like you imagined. The key is to get as much information as you can to help you make that decision. You should also consider seeking opportunities to shadow paralegals in an area of law

that you're interested in. NCPA offers a great mentoring program that provides a more intimate and hands-on method of learning about the paralegal profession. This is also a way to nurture professional relationships and possibly get your foot in the door as your mentor can attest to your hard work and character.

Volunteering is another good way to make connections and stand out. Paralegals and attorneys serve as judges and jurors as well as behind-the-scenes at local high school mock trial competitions. If you love children,

you can serve as a Guardian ad Litem or consider volunteering for Disability Rights North Carolina. Also ask for ways to volunteer in the paralegal association(s) that you join. There are plenty of volunteer opportunities which provide a means to make contacts while giving back to the community and may be the area that strikes the attention of employers on your resume'.

> Get certified. More and more, employers are requiring that paralegals be certified by the North Carolina State Bar. But, don't just stop there. Obtaining certification through the National Association of Legal Assistants will make you stand out and show potential employers that you are committed to the paralegal profession and add to your marketability. Also consider non-paralegal positions on your journey to gaining experience. You may start out as the receptionist, filing clerk or administrative assistant

but you have now gained internal contacts who can serve as references for the position you have your eye on.

I leave you with this: Never stop learning as technology and laws are ever changing. In all your learning, never forget to pass your knowledge on to others.

#### Mary Wade Brunk UNC Chapel Hill Paralegal Program 1st Place 2014 NCPA Student Scholarship Winner

### "I have chosen to be a paralegal..."

I am beginning a journey, a new challenge - my new mission. I am becoming a paralegal to experience the challenge of learning the law and to share what I learned in my previous career with those I meet in my new career – attorneys, fellow paralegals, and clients. After more than a decade working in higher education with student-athletes, I lost my spark. I value my years of experience in the field, specifically the opportunities to interact with a diverse

group of students. Forging relationships that promote success, offer support, and ultimately raise the bar have been essential components of my work, and I want to transfer these elements to my work as a paralegal.

Three years ago, I had no idea that simply fulfilling my civic duty as a United States citizen would be the first spark in my recent decision to become a criminal law paralegal. I was selected to serve on the jury for a murder trial in Atlanta, GA. My first experience reporting for jury duty,

and I was not only selected, but also later 'chosen' as the foreperson. I soaked in as much of the experience as I could. I dismissed my colleagues' suggestions that I weasel my way out of being selected. I wanted to be selected, and while I knew little of what serving as the jury foreperson would entail, I stepped up to the plate and dove in. Often more comfortable observing a group's interaction, I found myself naturally inclined and eager to contribute to the weeklong deliberations. I trusted myself and knew that I would uphold my duty to do everything in my power to lead my fellow jurors through a just analysis of the evidence. I felt a genuine sense of duty and respect for the process; and, while it took me much longer than others to reach my determination of a verdict, I was confident in the role I played and the effort I made to seek justice through the application of the law.

Unable to reach a unanimous verdict, our hung jury led to a mistrial. Following that initial trial, I maintained communication with the Senior District Attorney as she prepared for a retrial. Discussing the intricacies of her



argument, controversies in the deliberation room, and the significance of circumstantial evidence when limited physical evidence existed were frequent topics. She, without a doubt, was genuinely enthusiastic when I shared my career change with her.

Around this same time, a member of the NFL's Atlanta Falcons' Operations staff approached me about one of the team's players who had recently enrolled in his final course

> for college graduation and needed a tutor. The course: Sociology of Law. A sociology major in college, I was comfortable with the material; however, when it came down to it, I knew very little about the intricacies, technicalities, and realities of the law. I eagerly accepted the tutoring assignment, both to educate myself and to teach my student. Not only did I enjoy my experience as a tutor; I was fascinated by the content.

> In January 2013, I left higher education after more than a decade in the field and relocated to North Carolina. I did a great deal

of soul-searching, and while I was figuring out just what I wanted to do, I found myself participating in jury focus groups. Something continued to draw me back to the legal field. How two sides could apply the law to the very same case, and make two distinctly opposing arguments reflects my appreciation for the very nature of what makes every interaction, every situation so unique: perspective. I found my spark again.

Perhaps my experiences as a jury foreperson, tutor, and research participant should have triggered something in me sooner – something that would make it clear that I should head in this direction and explore work as a paralegal; or, perhaps not. While I did not anticipate undergoing a career change in my mid-thirties, I am confident and energized about my decision. I am prepared to face the intellectual challenge, necessity to problem solve, and opportunity to navigate a complex system. I am deadline driven, work with a sense of urgency, and value my integrity with high regards. I want to contribute to the professional advocacy of paralegals. I want to raise the bar.

#### "I have chosen to be a paralegal..."

Much of my professional career has been spent working in the Banking/Brokerage field, first as a Financial Advisor and then as an Operations Manager for a branch office. In addition to financial matters, I learned about compliance, ethics, and working with clients to help them achieve their goals. In my last job, working with the General Counsel at a small health care company, I learned about contracts, corporation organization, acquisitions, and in a limited role, malpractice litigation. Many of my skills and experience transitioned nicely into the legal field and I was always attentive when I worked with attorneys and paralegals. Occasionally I thought about attending a paralegal program to explore my interest in the legal profession but always stopped short of applying because I had a stable job and felt I was too old to go back to school.

In August 2012 I was laid off when my company was acquired by a new company. My husband encouraged me to stop talking about paralegal school and follow my dream. Our children are grown and it was time to for me to further my education. There truly were no more excuses; it was time to take on the challenge or live with the "what ifs" for the rest of my career. For many years, I have had taped to my desk a quote from Eleanor Roosevelt: "Do one thing every day that scares you." It seemed like a good time to take her advice.

I was absolutely petrified when I started school in August 2013. Since it had been years since I had officially been a student, my daughter helped me organize my classes in a way that made sense to me. As the anxiety lessened and my studies began, I learned that I love being a paralegal. Who wouldn't love a job where you get to read, research, write, organize, and work with clients and attorneys? These are all tasks that I have performed in varying degrees throughout my career; to have them come together in one job description is pure heaven for me.

Being a paralegal has finally brought satisfaction to my professional life. I always felt like there was something missing from my work life. While I have had a fulfilling career to this point, I was always looking for new challenges. There was an underlying boredom sometimes that I was not using my brain to its fullest capacity. It is an amazing feeling to wake up in the morning ready to learn and be of service to others.
